

Rental conditions Mobile home and nature of the mobile home

- 1- Reservation procedure: Please return the two signed contracts, with the deposit. The deposit corresponds to 25% of the total price of your stay + the application fee. The application fee is 15€. The reservation will only become final with our agreement according to availability upon receipt of the deposit, then we will send you a confirmation, your receipt and a contract. They are mandatory and incompressible. They are due once in the current year. The balance of the stay is payable in full on the day of arrival.
- 2- A deposit of €800 (cheque or cash) will be requested upon arrival. This deposit will be returned to you after inventory and inventory (except in case of breakage, possible damage or lack of cleanliness) on the day of your departure.
- 3- Payment Method: The campsite accepts payment by credit card, cash, cheque, ANCV and bank transfer. In the case of a remote sale (CB), we thank you to communicate to the campsite with the signed rental contract, the 16 digits of your credit card, the expiry date and the cryptogram. In the case of a transfer thank you for informing us and we will send you our RIB/IBAN by e-mail
- 4- For any residence not returned in a state of perfect cleanliness, a deduction of € 60.00 (cleaning at the end of stay) will be operated on the amount of the deposit (for the models Super Mercury, Super Venus and Super Astria), and € 70.00 (for the model Super Titania)
- 5- The rental includes access to the services of the campsite and the heated swimming pool between May 1st and September 30th.
- 6- The tourist tax is in addition to the amount of the stay, it is calculated according to the number of adults present during the stay and per night. Its amount is 0.66€ (0.60€ intercommunal tax and 0.06€ additional tax CD 17).
- 7 -Each night of the stay not used (absence, delay, early departure) will be at your expense. After 48 hours of delay (without notice), your mobile home will be considered free.
- 8- Sheets and towels are not provided. Pillows and duvets are provided. Charcoal barbecues are prohibited, only gas or electric barbecues are allowed.
- 9 - Pet: Only one small cat/dog is accepted per rental with extra charge (3.00 euros per night). He is admitted on condition that he has been declared with the vaccination record. The dogs are kept on a leash and must under no circumstances remain in the rental in the absence of their owners.
- 10- Cancellation/optional insurance but advised: amount 30.00€
Liability insurance is mandatory.
Camping ESSI declines all responsibility in case of damage due to falling branches, storm or flight.
- 11- Severance pay: In the case only of subscription to cancellation insurance and on presentation of proof in case of illness, refusal of vacation by the employer, mechanical breakdown of the vehicle or loss of work, (after verification and if the proof is valid), the total price of the stay less the application fee will be refunded after receipt of the supporting documents. The application fee of 15€ will be kept by the Campsite. Once your rental booking has been confirmed and in the event that, except in case of force majeure, we could no longer accommodate you, either on our campsite or on another establishment of the same category within a radius of 50 Km, reciprocally, such compensation would be due to you.
- 12- The behaviour of the occupants of the campsite must be consistent with the family destination of the campsite, therefore children, minors, unaccompanied may not be admitted.
- 13- Occupancy is limited to one family or 2 persons for the Super Astria, 4 persons for the Super Venus, 6 persons for the Super Mercury and the Super Titania.
- 14- Rules of procedure: staying at the campsite implies acceptance of the provisions of the rules and an undertaking to comply with them. Payment is available on request
